The DV Lottery is a randomized process, and selection does not guarantee a Green Card. Applicants must still meet all other eligibility criteria and successfully complete the subsequent application steps.

Asylum and Refugee Status: Protection for Those Fleeing Persecution

For individuals who have fled their home country due to persecution or a well-founded fear of persecution based on race, religion, nationality, membership in a particular social group, or political opinion, asylum and refugee status offer a pathway to protection and, eventually, a

Green Card.

1. **Asylum:** Individuals can apply for asylum either at a U.S. port of entry or within one year of arriving in the U.S. If granted asylum, they can apply for a Green Card one year after being granted asylum status.
