However, Malouf does not present memory as a static entity. Instead, Ovid actively engages with his memories, reinterpreting them, and weaving them into his new reality. His poems, once expressions of Roman life, begin to be reshaped by his experiences in Tomis.

This reimagining of the past is central to Ovid's ability to adapt. He doesn't simply mourn what he has lost; he finds ways to integrate it into his present. The "imaginary life" is thus a fusion of past and present, of what was and what is becoming. Malouf's sophisticated use of narrative allows for a fluid interplay between Ovid's recollections and his current observations, creating a rich tapestry of experience.

The act of writing, even in isolation, becomes a way for Ovid to process his experiences and to assert his continued existence. His new poems, though perhaps never written down, exist within him, a testament to his enduring creative spirit. This highlights the resilience of the human imagination, its capacity to transform even the most desolate circumstances into a source of meaning and artistic expression.
