Any member of Congress can introduce a bill. Revenue bills must originate in the House. Once introduced, a bill is assigned to a relevant committee. Presidential Action: Signing, Vetoing, or Pocket

Once a bill has passed both houses of Congress, it is sent to the President. The President has several options: sign the bill into law, veto the bill (rejecting it), or allow it to become law without signing it after 10 days (excluding Sundays). If Congress adjourns within that 10-day period and the President does not sign the bill, it is considered a pocket veto, and the bill does not become law.

Congress can override a presidential veto with a two-thirds vote in both the House and the Senate, a difficult but not impossible feat.
