3. **3NF:** Further refines 2NF by ensuring that non-key attributes are not transitively dependent on the primary key. This means non-key attributes should only depend on the primary key, not on other non-key

attributes.

While higher normal forms exist (e.g., Boyce-Codd Normal Form - BCNF, Fourth Normal Form - 4NF, Fifth Normal Form - 5NF), achieving 3NF is often sufficient for most applications. Over-normalization can sometimes lead to performance issues due to excessive joins, so a balance needs to be struck.

3. Denormalization: Optimizing for Read Performance

In some scenarios, particularly for read-heavy applications or data warehousing, denormalization might be employed. This involves intentionally introducing some redundancy back into the database to improve query performance by reducing the need for complex joins. Denormalization should be done judiciously and with a clear understanding of the trade-offs.
