For students who are **visually impaired**, tactile manipulatives offer a crucial sensory input. For **ELL students**, they provide a common ground for understanding mathematical terms and concepts, regardless of their English proficiency.

Manipulatives Across the Curriculum

The application of manipulatives is not confined to elementary math. Their utility extends across various mathematical strands and grade levels.

Early Childhood and Elementary Grades

and deeper, self-directed learning.

Differentiation

Recognize that students will engage with manipulatives differently. Some may grasp the concept quickly, while others may need more time and varied approaches. Use manipulatives to differentiate instruction, providing more support for struggling learners and challenging advanced learners with more complex problems.
