Her inability to distinguish his "gift" from others is also symbolized by this unrestrained expression of joy. * **The Bronze Neptune:** This final image is a stark representation of the Duke's own self-perception. He sees himself as a powerful, dominant figure, capable of taming and controlling lesser forces, much like Neptune with the sea-horse. It underscores his belief in his own absolute authority and his desire for subjugation. * **The Curtain:** The "curtain" hiding the portrait is not just a practical element; it symbolizes the hidden truths and the layers of deception that surround the Duke. He controls what is revealed, just as he controlled the Duchess's life and her expressions of joy.

Literary Devices: Crafting the Chilling Narrative

Browning employs several key literary devices to achieve the poem's powerful effect: * **Dramatic**

Monologue: This is the core of the poem. The entire narrative is delivered by a single speaker, revealing their personality, motives, and worldview through their own words. The audience is privy to the Duke's thoughts, but also his biases and his self-deception. * **Iambic Pentameter and Rhyme Scheme:** The poem is written in iambic pentameter with an AABB rhyme scheme. This creates a seemingly regular and measured rhythm, which contrasts sharply with the disturbing content being conveyed. This creates a sense of unease, as the smooth flow of the verse masks the darkness of the Duke's intentions. *

Enjambment: The use of enjambment, where a sentence continues over a line break, creates a conversational tone and allows the Duke to meander through his thoughts, revealing more about himself with each pause and continuation. * **Irony:** The poem is steeped in dramatic irony. The reader understands the sinister implications of the Duke's words far better than the envoy, and likely better than the Duke himself fully comprehends. His attempts to appear cultured and benevolent are undermined by his chilling revelations.
