Example with nested grouping: In the expression $5 + [2 * (6 - 3)]$, you would first solve the innermost parentheses: $6 - 3 = 3$. Then, you would solve the expression within the brackets: $2 * 3 = 6$. Finally, you would add 5: $5 + 6 = 11$.

2. **Exponents (Orders)**

4. Addition and Subtraction (Left to Right)

Similar to multiplication and division, addition and subtraction are performed from left to right as they appear in the expression. They have equal precedence.

Example: In the expression $15 - 3 + 7$,

1. From left to right, first subtract: $15 - 3 = 12$.
2. Then, add: $12 + 7 = 19$.

If you were to add first ($3 + 7 = 10$) and then subtract ($15 - 10 = 5$), the answer would be incorrect.

Example: In $8 + 2 - 5$, perform addition first: $8 + 2 = 10$. Then perform subtraction: $10 - 5 = 5$.

To avoid these errors, practice consistently. Work through a variety of problems, and don't be afraid to review the steps. Visual aids, like writing out each step clearly, can be very helpful, especially for more complex expressions.
