2. However, there is no rational number that is the *least* upper bound. Any rational number r proposed as the supremum would be either less than $\sqrt{2}$ (in which case there's a larger rational number still less than $\sqrt{2}$ and in V) or greater than $\sqrt{2}$ (in which case it's not the *least* upper bound).

3. This illustrates why the completeness axiom is so important for the real numbers. In $\mathbb{R}$, $\sup(V) = \sqrt{2}$.

Infimum: The Dual Concept

Just as the supremum is the least upper bound, its dual concept is the **infimum**, denoted as $\inf(S)$ or $\inf S$. The infimum is the **greatest lower bound** of a set. It's the largest element l such that for all $x \in S$, $l \leq x$. Like the supremum, the infimum does not need to be an element of the set.

For any non-empty subset S of $\mathbb{R}$ that is bounded below, its infimum exists. The relationship between supremum and infimum is also important:
