However, the ceremony was famously marred by the dramatic intervention of Captain Francis de Groot, a mounted officer of the New Guard, who slashed the ribbon before the Premier of New South Wales could do so, declaring the bridge open in the name of the people. Despite this act of defiance, the bridge was eventually opened to traffic, marking a triumphant moment for the city and the nation.

A Living Legacy: The Bridge Today

Today, the Sydney Harbour Bridge remains an indispensable part of Sydney's infrastructure and identity. It carries an average of 160,000 vehicle movements each day, a testament to its enduring functionality. Beyond its practical purpose, it is a magnet

for tourism, with the popular BridgeClimb offering unparalleled panoramic views of the harbour and city. The bridge has witnessed countless events, from national celebrations to moments of quiet contemplation, solidifying its place in the hearts of Australians.
