7. **SMP 7: Look for and make use of structure.** Students are encouraged to recognize patterns and structures in mathematical concepts and to use this understanding to simplify complex problems.
8. **SMP 8: Look for and express regularity in repeated reasoning.** This involves students observing patterns and regularity in problem-solving and generalizing them to create efficient methods or rules.

The integration of the SMPs is a key differentiator, moving beyond rote memorization towards a deeper, more conceptual understanding of mathematics. These practices are essential for lifelong learning and critical thinking.

The Content Standards: The 'What' of Learning Math

Complementing the Practices are the Content Standards, which outline the specific mathematical knowledge and skills students are expected to acquire at each grade level. These are organized by mathematical domains, providing a coherent progression of learning.

Kindergarten through Grade 5: Building Foundational Understanding

The early grades focus on establishing a strong foundation in number sense, operations, algebraic thinking, measurement and data, and geometry. Key areas include:

1. **Counting and Cardinality (K):** Understanding counting sequences and quantities.
2. **Operations and Algebraic Thinking (Grades 1-5):** Developing fluency with addition, subtraction, multiplication, and division, and understanding properties of operations and algebraic relationships. This includes concepts like solving word problems and understanding patterns.
3. **Number and Operations in Base Ten (Grades 1-5):** Understanding place value and performing operations with multi-digit numbers.
