Many questions are accompanied by stimulus materials. Don't just skim them. Read them thoroughly, highlighting key phrases, dates, statistics, or arguments. For graphs and charts, pay close attention to the labels, axes, and trends. Understand what the stimulus is trying to convey before you even look at the question.

Understand the Question's Demand

Each question asks you to do something specific: identify, analyze, compare, contrast, explain, or apply. Look for keywords in the question that indicate what is expected of you. For instance, "Which of the following best describes..." requires you to select the most accurate option, while "Which of the following is an example of..." asks for a concrete illustration.

Eliminate Incorrect Answer Choices

This is a powerful strategy. Go through each answer choice and try to eliminate those that are clearly wrong. Often, you can discard two or even three options, significantly increasing your chances of selecting the correct answer from the remaining choices. Look for answers that are factually incorrect, contradict the stimulus, or are irrelevant to the question.

Beware of Distractors

Test creators are skilled at developing plausible but incorrect answer choices, known as distractors. These often use jargon correctly but in the wrong context, are partially correct, or represent common misconceptions. Be vigilant and ensure your chosen answer directly addresses the question and is fully supported by your knowledge and the stimulus.

Connect to Course Concepts and Principles

The AP® Government and Politics exam tests your understanding of foundational concepts. When answering a question, try to connect it to the relevant principles, theories, or historical events you've studied. For example, if a question discusses the power of the President to issue an executive order, think about the concept of executive power and its constitutional basis.

Practice with Official Materials

The most valuable practice comes from official College Board resources. Use released AP® Government and Politics exams and practice questions. These materials are designed to mirror the actual exam in terms of difficulty, question style, and content coverage. Analyze your performance on these practice tests to identify areas where you need more study.

Time Management is Crucial

With 55 questions in 80 minutes, you have about 1 minute and 27 seconds per question. Practice pacing yourself. Don't get bogged down on any single question. If you're struggling, make your best guess, flag it, and move on. You can always return to it later if you have time. Develop a rhythm that allows you to comfortably work through the entire exam.

Understand the Difference Between Fact and Opinion

Some questions may present a statement or excerpt that contains opinions. It's crucial to distinguish between factual claims that can be verified and subjective opinions. The question will often ask you to identify a factual claim or an opinion presented in the stimulus.
