Successful resolution is crucial for gender identity and moral development. * **Latency Stage (6-puberty):** Sexual urges are suppressed, and focus shifts to social and intellectual development. * **Genital Stage (puberty onwards):** Maturation of sexual interests and the development of healthy adult relationships. While these stages are no longer accepted as a rigid developmental blueprint by many contemporary psychologists, they offer a compelling narrative about the enduring impact of early childhood experiences on adult personality.
