2. **Delayed Feedback:** Clients only see the working product very late in the lifecycle, meaning feedback is often received when significant rework might be needed.
3. **Higher Risk for Complex Projects:** If requirements are not fully understood upfront, the entire project can be jeopardized.

Other traditional methodologies, like the **Critical Path Method (CPM)** and the **Program Evaluation and Review Technique (PERT)**, focus on detailed scheduling and identifying dependencies to optimize project timelines. CPM is particularly effective for defining the longest sequence of tasks that determines the minimum project duration, while PERT is useful for projects with uncertain task durations, often employing probabilistic estimates.

Agile Project Management: Embracing Change and Iteration

Kanban: Visualizing Workflow

Kanban is another popular agile method that focuses on visualizing workflow, limiting work in progress (WIP), and maximizing efficiency. It uses a Kanban board to represent different stages of the workflow, allowing teams to see the status of tasks at a glance.

1. **Visualize Workflow:** Tasks are moved across columns representing stages (e.g., To Do, In Progress, Done).
2. **Limit Work in Progress (WIP):** Setting explicit limits on the number of tasks allowed in each stage prevents bottlenecks and improves flow.
3. **Manage Flow:** Teams continuously monitor and improve the flow of work.
4. **Make Policies Explicit:** Workflows and rules are clearly defined and visible.
5. **Implement Feedback Loops:** Regular reviews and discussions help identify areas for improvement.
6. **Improve Collaboratively, Evolve Experimentally:** Teams work together to make incremental changes and learn from them.

Pros of Agile:

Cons of Agile:
