When adaptive mechanisms are insufficient or when cells are exposed to injurious agents, cellular injury occurs. This can be reversible in its early stages, but persistent or severe injury leads to irreversible damage and cell death.

1. **Reversible Injury:** Characterized by cellular swelling (hydropic change) and the appearance of fatty changes (steatosis), often due to ATP depletion, altered membrane

permeability, and loss of ion homeostasis.

2. **Irreversible Injury:** Marked by the breakdown of cell membranes, leakage of cellular contents, and the initiation of programmed cell death (apoptosis) or unprogrammed cell death (necrosis).

Mechanisms of Cell Death: Necrosis vs. Apoptosis

Necrosis is a pathological process, typically resulting from acute injury, leading to uncontrolled cell breakdown and inflammation. Infectious diseases are caused by pathogenic microorganisms, including bacteria, viruses, fungi, and parasites. The

pathogenesis involves the interaction between the host and the pathogen.

1. **Bacterial Infections:** Pathogenesis often involves bacterial toxins, enzymes that degrade host tissues, and the induction of inflammation. Examples include mastitis in dairy cows, pyoderma in dogs.
2. **Viral Infections:** Viruses hijack host cell machinery for replication, often leading to cell lysis or dysfunction. Viral pathogenesis can be complex, involving immunopathology and latency. Canine distemper, feline leukemia virus are significant examples.

These diseases arise from alterations in an animal's genetic makeup or errors during development. They can range from subtle metabolic defects to gross structural abnormalities.

1. **Heritable Diseases:** Passed down through generations, caused by gene mutations. Examples include hip dysplasia in large breed dogs, certain congenital heart defects.
2. **Chromosomal Abnormalities:** Alterations in chromosome number or structure, less common in veterinary medicine than in humans but still significant.
3. **Congenital Malformations:** Structural defects present at birth, which can be caused by genetic factors, environmental teratogens (e.g., certain medications or infections during pregnancy), or unknown causes.

Environmental and Toxicologic Diseases: The Impact of External Factors

Exposure to toxins, pollutants, radiation, and physical trauma can all lead to disease.

1. **Toxicology:** The study of the adverse effects of chemicals on living organisms. Pathogenesis involves absorption, distribution, metabolism, and excretion of toxins, and their interaction with cellular targets. Examples include poisoning from rodenticides, herbicides, or heavy metals.
2. **Trauma:** Physical injury, such as fractures, blunt force trauma, or burns, leads to direct tissue damage and inflammation.
3. **Nutritional Diseases:** Deficiencies or excesses in essential nutrients can lead to a wide range of diseases, impacting growth, metabolism, and immune function. For instance, calcium deficiency leading to rickets.

Immune-Mediated Diseases: The Immune System Turned Against Itself
