2. **Data Type:** Short Text (You could also use Hyperlink, but Short Text is simpler for beginners).
3. **Description:** The customer's email address.
5. **PhoneNumber:**
 1. **Field Name:** PhoneNumber
 2. **Data Type:** Short Text (We use Short Text here to accommodate different phone number formats, including hyphens and country codes. If you only needed to perform calculations on phone numbers, Number might be considered, but it's less flexible).
 3. **Description:** The customer's phone number.
6. **RegistrationDate:**
 1. **Field Name:** RegistrationDate
 2. **Data Type:** Date/Time
 3. **Description:** The date the customer registered.

Setting the Primary Key

The **Primary Key** is a field (or a combination of fields) that uniquely identifies each record (row) in a table. It ensures that no two records are identical and is crucial for establishing relationships between tables. In our "Customers" table, "CustomerID" is our primary key. Access usually suggests "ID" as the primary key when you create a new table, which is

typically an AutoNumber field.

To set the primary key (if it's not already set):

1. Click the gray square to the left of the "CustomerID" field name to select the entire row.
2. Click the "Primary Key" button on the "Design" tab of the "Table Tools" ribbon. You'll see a small key icon appear next to the field name.

Now, save your table by clicking the floppy disk icon (Save) or pressing Ctrl+S.

Switching Back to Datasheet View and Entering Data

To enter data into your table, you need to switch back to Datasheet View.

1. Click the "View" button on the "Home" tab and select "Datasheet View."
2. You'll see your table structure with empty rows. Click in the "FirstName" field of the first row and start typing your customer's name.
3. As you type, Access will automatically assign a CustomerID (starting from 1) and you can fill in the rest of the details.
4. Press the Tab key to move to the next field, or click in the field you want to edit.

5. When you move to a new row, Access automatically saves the previous one.

Let's enter a few more records to populate our "Customers" table. Remember, the "CustomerID" will be automatically generated for you.

7. To see your results, click the "Run" button (an exclamation mark) on the "Query Design" tab.

Access will display a datasheet showing only the customers who registered in 2023. Save your query by clicking the save icon and giving it a name, like

"CustomersRegisteredIn2023."

More Query Examples

1. **Finding customers by last name:** In the "Criteria" row for "LastName," type "Smith".
2. **Finding customers whose email contains "@example.com":** In the "Criteria" row for "EmailAddress," type Like "*@example.com". The asterisk (*) is a wildcard character meaning "any characters."
3. **Combining tables:** If you create a query that includes fields from both "Customers" and "Orders" (thanks to your relationship!), you can see which customer placed which order, along with the order date.
