7. 7. Satan has been the best friend the Church has ever had, because he has kept it so busy eating up moral indignation with ☹️👹👹👹
8. 8. Satan represents all of the sins, for, after all, they all lead to carnal gratification!
9. 9. Satan has been the key to the continuation of the Church, because he has served it so well.

### **The Eleven Satanic Rules of the Earth:**

These rules provide practical guidelines for living a Satanic life:

1. 1. Indulge your own desires.
2. 2. You are responsible for your own existence.
3. 3. Treat those who deserve it with kindness.
4. 4. Do not harm those who do not harm you.
5. 5. Do not take what is not yours.
6. 6. Do not harm animals unnecessarily.
7. 7. Never take credit for something that is not yours.
8. 8. Never betray yourself or those you care about.
9. 9. Do not harm children.
10. 10. Do not harm the innocent.
11. 11. Do not harm yourself.

Unlike theistic Satanism, which often involves the worship of Satan as a divine entity, LaVeyan Satanism views Satan as a symbolic representation of human nature. This crucial distinction separates it from many other occult and esoteric traditions that involve deity worship. LaVey's Satanism is fundamentally anthropocentric, placing humanity and its desires at the center of its worldview. The rituals and ceremonies described in the book, such as the "infamy ritual," are psychological tools designed to channel and focus emotions, not to invoke supernatural beings.

The Church of Satan's rejection of altruism and its emphasis on self-preservation and personal fulfillment are also key differentiators. Where many religions preach humility and sacrifice, LaVeyan Satanism champions pride and the pursuit of pleasure. This often leads to the misconception that Satanists are inherently evil or destructive, but the philosophy is more nuanced, focusing on a realistic and pragmatic approach to life.
